KNOW ALL MEN BY THESE PRESENTS: Whereas WESTVIEW DEVELOPMENT COMPANY, a North Carolina Corporation having its principal office in Forsyth County, North Carolina (hereinafter "Declarant"), is the owner of certain real property as shown on the survey map entitled "Lissara On-Site and Off-Site Stream Preservation Buffers" dated January 22, 2008 by Coe Forestry and Surveying, more particularly described in Exhibit "A" attached hereto and by this reference incorporated herein, and whereas Declarant desires to impose certain restrictions and conditions upon present and future owners of said real property;

**NOW, THEREFORE,** Declarant hereby covenants and agrees, for itself and its successors and assigns, with all persons, firms, corporations, or other parties hereafter acquiring title to any part of said real property, that all of the said real property is hereby subjected to the following restrictions and conditions as to the use thereof, said conditions and restrictions to be appurtenant to and to run with said real property, by whomsoever owned.

The areas shown on the above-referenced survey of Tax Block 4609, Lot 3B are designated as stream preservation buffers and shall be maintained in perpetuity in their natural or mitigated condition. No person or entity shall perform any of the following activities within such stream preservation buffers:

- a. fill, grade, excavate or perform any other land disturbing activities other than as heretofore agreed to ("excepted area") by the U. S. Army Corps of Engineers, and which agreed to work may be repaired or replaced but not expanded as to size or use
- b. cut, mow, burn, remove, or harm any vegetation
- c. construct or place any roads, trails, walkways, buildings, mobile homes, signs, utility poles or towers, or any other permanent or temporary structures other than as heretofore agreed to ("excepted area") by the U. S. Army Corps of Engineers, and which agreed to work may be repaired or replaced but not expanded as to size or use
- d. drain or otherwise disrupt or alter the hydrology or drainage ways of the stream preservation buffer

- e. dump or store soil, trash, or other waste
- f. graze or water animals, or use for any agricultural or horticultural purpose
- g. except that one (1) driveway crossing shall be allowed within the length of "Stream Preservation Buffer A" for a maximum of seventy-five (75) feet at a location to be determined upon construction of a single-family residence on a future lot

This covenant is intended to ensure continued compliance with the mitigation condition of a Clean Water Act authorization issued by the United States of America, U.S. Army Corps of Engineers, Wilmington District, Action ID #200520968, and therefore may be enforced by the United States of America. This covenant is to run with the land, and shall be binding on the Owner, and all parties claiming under it.
