AMENDMENT TO THE DECLARATION OF THE COVENANTS, CONDITIONS, AND RESTRICTIONS FOR OAK VALLEY (RAE'S CREEK at OAK VALLEY)

WHEREAS, Declarant herein caused a Declaration of Covenants, Conditions and Restrictions for Oak Valley to be recorded in Book 175, Page 143, Davie County Registry; and

WHEREAS, Declarant reserved the right to impose additional Restrictive Covenants upon individual platted neighborhoods within Oak Valley;

NOW THEREFORE, Declarant herein imposes the following additional restrictions on those properties contained on a Map of Rae's Creek at Oak Valley, as recorded in Plat Book 12, Page 449, Davie County Registry:

- 1. Each residence must utilize water-conservation fixtures and low-flush toilets;
- 2. No residence shall be constructed on any lot containing less than the following minimum square footages of heated living area;
 - For a 1-story dwelling: a minimum of 1800 square feet;
 - For a 1-1/2 story dwelling: a minimum of 2200 square feet;
 - For a 2-story dwelling: a minimum of 2200 square feet:
 - For a split foyer/level dwelling: a minimum of 2000 square feet;

The above square footage restrictions do not include areas finished in a basement or lower level. The split-level minimum is for the two principal levels of the dwelling.
